ABSTRACT

The Cyber-attacks have significantly increased during the pandemic with financial institutions being a target of choice. Therefore, supervisors should strengthen: regulation, supervision and oversight of supervised financial institutions and build their skills. The webinars will cover the threat landscape and the concepts of cyber, cyber risk, cyber security and cyber resilience and, building on the guidelines issued by standard setters (BCBS, FSB, IAIS), how to address them from the point of view of supervisors of financial institutions.

Involved in various international cyber groups, including the G7 Cyber Expert Group, he participated in drafting the CPMI-IOSCO Cyber Guidance, different G7 Fundamental Elements and the FSB Cyber Lexicon.

Mr. Jacques Loubert is the Financial Supervision and Regulation advisor with IMF/SARTTAC since August 2017. Jacques retired from the Banque of France in July 2017 as Inspector General and Head of Mission with the French Prudential and Resolution Supervisory Authority.
