ABSTRACT

This webinar on Measuring Human Capital is second in the SARTTAC webinar series on System of National Accounts (SNA) update issues. A particular feature of the upcoming update of the 2008 SNA is the broadening of the national accounts framework to better account for issues affecting well-being and sustainability, with education and human capital being one. The concept of human capital is not part of the “asset boundary” of the 2008 SNA. The guidance note on 2008 SNA update recommends that extended national accounts for human capital can be developed without changing the core SNA.

WEBINAR OBJECTIVES

The webinar aims at providing participants with an understanding of methods for measuring human capital and challenges associated with its measurement, drawing on body of international guidance available on the subject. As human capital is an issue relevant to the update of SNA, this webinar aims to contribute to discussion on the issues and challenges surrounding measurement of human capital.
